Position Description

The goal of the Healthy Bay Area Futures Program is to reduce tobacco-related health disparities in the LGBTQ community through increased availability of tobacco cessation resources delivered by culturally competent providers. The Project Director will oversee the day to day functions of the program which includes working with stakeholders and technical experts to design an innovative and evidence based tobacco cessation treatment and referral protocol for providers and implementing the program in local FQHCs and health organizations that serve the LGBTQ community. In addition, the Project Director will work to build a coalition to support the program and policy objectives.

Essential Functions

- Review program objectives and ensures program deliverables are being met
- Recruit, hire and supervise Program Coordinator
- Outreach and build relationships with new partners, provider sites, experts and potential coalition members
- Work with key experts to develop a protocol that includes best practices for engaging the transgender community in smoking cessation
- Train provider sites across the region to implement the protocol
- Be in regular contact with the California Tobacco Control Program, the seven Local Lead Agencies in the San Francisco Bay Area, the Tobacco Education Clearinghouse of California, and the Statewide LGBTQ Coordinating Center
- Recruit and maintain members to form a diverse Bay Area LGBTQ Tobacco Policy Coalition
- Collaborate with key experts, administrators and stakeholders, including coalition members, the Center for Tobacco Cessation, and the LOOP to develop a tobacco cessation and referral health provider training program

- Plan, coordinate and implement strategic planning sessions, coalition meetings, workshops and attend similar activities as an agency representative
- Supervise the development and preparation of reports, literature reviews, pamphlets, articles and training materials
- Provide training and technical assistance to providers and policy makers on LGBTQ-specific smoking cessation issues and treatment
- Regularly participate in conference calls, webinars, and trainings regarding flavored tobacco and menthol cigarettes hosted by California Tobacco Control Program (CTCP), California Youth Advocacy Network, and The LOOP
- Work with collaborating partners and agencies to ensure strong partnerships are maintained
- Assists with other administrative duties as needed

- Familiarity with issues faced by the LGBTQ community, particularly the transgender community
- Experience implementing new programs
- Ability to travel locally across the region
- At least two years' experience supervising and leading teams

- Demonstrated experience community organizing and mobilizing communities for action
- Strong written and verbal communication skills
- Strong organization skills
- Self-directed, motivated and flexible with the ability to work independently and as part of a team
